IBM AND APPLE DISCUSS MOVING TO MACBOOKS OVER THINKPADS BY LENOVO

We all remember, don't we, when an IBM computer in the office was the standard and the operating system was DOS? Well, in 2005, "IBM shed its hardware business and sold its ThinkPad and PC business to Lenovo," says Chuong Nguyen in his August 1, 2015 article in *The Economic Times*." In recent discussions, IBM's Chief Information Officer Jeff Smith has spoken with Apple's Chief Information Officer to increase Mac adoption at IBM. In another part of a recorded interview, Smith said he had discussed with Apple CEO Tim Cook of the potential shift to MacBooks so that up to 50 to 75% of IBM employees could move to MacBooks from their Levono ThinkPads. This could mean that IBM alone could "consume" up to 150,000 to 200,00 Macs annually. This represents more than eight times the number that Apple's current enterprise clients buy.

Author Choung Nguyen gives the history of IBM and its relationship with Apple as former rivals. Now, they are

collaborating on building 100 enterprise apps.
Nguyen is awaiting updates on the current status of the MacBook transition as well as the collaboration on enterprise apps as part of this partnership.

EPSON ECOTANK PRINTERS TO REPLACE INKJET CARTRIDGES WITH TANKS

Epson has a new line of printers called <u>EcoTank</u> printers that use high-capacity tanks instead of cartridges. To refill the tanks, you use "ultra low-cost replacement ink bottles."

Printer models include wireless, print, copy and scan. The more expensive models add fax and Ethernet features.

Depending on which all-inone model you buy, the EcoTank can print from 4000 black/6500 colors copies per refill and up to 20,000 black/20,000 color copies per refill for the

professional/business model. The ads say the printers are "loaded & ready...includes 2 years of ink."

Estimates for printer ink costs ranged widely, but in 2012, a conservative estimate said the cost was \$5,654/ounce for printer ink versus \$3,180 for Chanel #5 perfume. Also, the Epson Printer manufacturer has taken the step to reclaim some losses from generic-brand inkjet refills.

Epson has presented some of its own arithmetic on how much users will save. According to the company, four ink bottles are sufficient to print 4,000 black pages and 6,500 color pages on the new consumer-oriented models. Printing the same number of pages using one of Epson's standard inkjet printers would require 20 sets of cartridges. At \$40 each, the total price for cartridges would be \$800—about \$750 more than what you're expected to spend on ink for an EcoTank model.

Until you purchase your new Epson EcoTank printer, here are some guidelines to save ink on your current inkjet printer. From *Consumer Reports:* Some ink . . . must be used to maintain the health of the print head; some ink is residual; and some ink evaporates. To conserve on ink usage, first, you can leave the power on. Leaving the printer on all the time avoids triggering a maintenance cycle each time you use the printer. If the printer is switched off then it may do a longer clean. Inkjets left on consume very little power when not in use, so your ink savings should considerably outweigh the energy cost.

TRANSFER PHOTOS FROM iPHONE TO iMAC USING PREVIEW



Easiest method(s) yet!

On your Mac, click

on Preview, then connect your iPhone to your Mac. Go to File and click on "Import from iPhone."

Or, if you aren't next to your Mac, you can always email yourself the photo you just took so that you can download and put into your photos file at a later time

In addition, Preview contains image-editing tools that every Mac since the dawn of OS X has come with. It doesn't get much attention, but it contains image-editing tools that shouldn't be ignored, especially as they come for free. It can import from cameras and scanners directly from its File menu. Its Tools menu can find options to resize your image, rotate and flip it, and even make adjustments to exposure and color.

SNAPHEAL

Remove unwanted objects and fix imperfections in your photos

This cheap (\$12.99) app can remove unwanted items from your photos—people, cars, etc. Reviews from current users of this program say it's far easier to use than many other editing programs. For simple fixes to your photos, this may be good software to suit less aggressive editing. There is a pro version that costs more (\$39.99), but for simple fixes to your photos, the \$12.99 version may be good software to suit less aggressive editing. If your photo editing needs lean more toward restoration or retouching, Snapheal (Mac) provides a deliriously simple UI with the ability to remove unwanted objects like magic, or adjust shadows and highlights on dark or overexposed images.

MACKEEPER CLASS ACTION SETTLEMENT

If you purchased the software MacKeeper prior to July 8, 2015, you may be eligible for a class action settlement.

ZeoBIT has a class action suit against it for deceptive advertising claiming their software, MacKeeper, would enhance Apple Macintosh computer speed, performance and security by detecting and eliminating harmful errors and threats.

People eligible may receive an email with a link to "Notice of Class Action Settlement." and this includes a link to file claim online or to download a claim form for mail-in claim. Additionally, an Internet advertising campaign is planned as well as a website to notify those whose email addresses are no longer valid. Rust Consulting, the company contracted to administer the settlement,

plans to buy 16 million ad impressions through providers such as Xasis, an advertising platform, and Facebook.

As few as 1 to 2 percent of eligible people file claims resulting from class-action suits. That makes it likely that the MacKeeper customers who make the effort to make a claim will be fully reimbursed. But as the number of applicants rises, the refund value will proportionally fall from \$39.95.

One-third of the \$2 million will go towards attorney fees, leaving the remainder for refunds and other administration costs.

Those who object to the proposed settlement must contact the court by Sept. 21. The court will hold a final approval hearing on Oct. 16 where MacKeeper customers will be allowed to speak.
