#### FACEBOOK HOAX

A recurring warning for Facebook users to post a legal notice preventing Facebook from using your "pictures information, messages or posts, both past and future" is a hoax. Snopes says this notice was originally published on 04 June 2012 and last updated 14 October 2016. Jeff Gamet explained:

Posting that notice is worthless because using Facebook requires you to agree to their terms of service. [This notice] . . . sounds official, which is why so many people repost it. That said, you can't change Facebook's terms with this post, and the only way to keep the company from using your content is to not have a Facebook account.

Kim Komando responds to this as well saying that it doesn't take much "to create a convincing hoax." Another hoax she described was convincing millions of people that "drilling a hole in your iPhone 7 will reveal a hidden headphone jack." A video that was viewed by over 15 million viewers fooled some into destroying an iPhone.

If you hear something that nudges your common sense, run a quick internet search. The bottom line is this: If you post it online, it is there forever and anyone can get access to it, so be careful what you post.

Here's another comment about Facebook terms from the Watson Firm

Let me be very clear: posting this does absolutely nothing to protect what you post via social media. First, Facebook's terms are determined by the Terms of Service and intellectual property law. Second, the UCC is a model code and is not law. Where the UCC has been adopted, it only applies to commercial transactions, not intellectual property. Third, the "Rome Statute" establishes the International Criminal Court, which punishes war crimes, not civil matters. Posting this message is as relevant to protecting your legal rights as referencing Klingon law.

Let's get real then. What are your privacy rights on Facebook? As of today, January 5, 2015, the <u>Facebook user</u> terms of service provide for the following:

Understanding your rights online is incredibly difficult, even for attorneys. In fact, there are entire continuing legal education (CLE) seminars that attempt to educate attorneys about social media. The bottom line is this: if you post it online, it is there forever and anyone can get access to it, so be careful what you post.

### APPLE PRODUCTS SOLD ON AMAZON WERE COUNTERFEIT

In mid-October 2016, Apple Inc. sued Mobile Star LLC for selling counterfeit iPhone and iPad adapters and charging cables la-

beled as "genuine" and "official" on Amazon. The following is quoted from the law-suit filed by Apple Inc:

Counterfeit power products, such as those supplied by Mobile Star, pose an immediate threat to consumer safety because, unlike genuine Apple products, they are not subjected to industry-standard consumer safety testing and are poorly constructed with inferior or missing components, flawed design, and inadequate electrical insulation.

Apple reported that Amazon itself was the vendor and that a third-party Marketplace vendor did not sell the counterfeit power products. Mobile Star was the source for most of the counterfeit Apple products. Apple is not targeting Amazon.com in the lawsuit. After Apple notified Amazon.com about the problem, the products were removed from the online market-place.

Apple Inc. purchased over 100 iPhone devices, Apple power products, and Lightning cables and tested these products to determine that 90 percent of those items purchased were fakes.

A genuine Apple product should have the Apple logo on it and say, "Designed by Apple in California." My own personal Apple adapter shows these two identifiers plus "Assembled in China."

How to conserve battery power on iOS devices

- Keep gaming to a minimum.
- Reduce Facebook and other social media usage.
- Dim screen brightness and don't use screen as a flashlight.
- Disable Bluetooth unless using wireless headset or portable speakers (or other wifi connected gadgets).
- Disable GPS or location-based services. Google Maps allow downloaded maps for offline use.
