REUNION 9 UPDATE 9.08

[At our meeting last September 2008, Nancy Ratay presented Reunion, the "family tree" program for the Macintosh. Her demonstration to DAPI was very well presented and received and showed us that it can be fun and fascinating to document, store, and display information about your family and its history.]

Great news for Macintosh Reunion users! If you have an iPhone or iTouch, you can now have your family with you all the time. It is supposed to be transferable both ways. You have to have version 9.08 in order to use it and purchase a \$15 application for the communication link. To view a video about Reunion on the iPhone and iTouch visit: http://www.leisterpro.com/iphone/

This will also give you a listing of the Reunion for iPhone features. This looks just like what Mac users have been waiting for. The application runs very much like your computer edition and will transfer anything, including photos and sources that you have in your current Reunion file. It looks to be much more useable than MyRoots for PDAs which was about all you could do previously. Also, my iPod window was way too small to really see the family that way.

In addition to adding the new feature above, the following improvements were made and "fixes" were taken care of:

- •Improved date sorting in lists and reports.
- •Improved support for RTF index codes in reports going to NeoOffice.
 - •Improved the "Leister Home" web style to support longer names.
 - Fixed a problem with the Find Citation Detail function.
- Fixed a problem when importing family files containing new source types and new source fields.
- Fixed two problems with the privacy filter when used in Register reports.
 - Fixed a rare crash when exporting Temple Ready files.
 - Fixed a problem with Google Analytics.
 - Fixed a rare problem with saving sources in facts fields.
- Fixed a problem where marked sets would not work properly for family files containing more than 262,000 people.

- Fixed a rare crash when opening saved found lists.
- •Fixed a rare problem with duplicate files on web media pages.
- •Fixed a problem with web media pages reporting links to missing media files.
- Updated the LDS Temples file.
- Updated the US Presidents perspective events.

RIPIT – THE SIMPLE DVD RIPPER FOR MACS

www.ripitapp.com

Ripping is the process of

copying audio or video content to a hard disk, typically from removable media or media streams. With a little application called RipIt, you can download movie DVDs onto your hard drive on Macs using Leopard 10.5 or greater; this allows you to use your laptop longer because you're not spinning your hard drive and your DVD drive at the same time because you're movie is on your hard drive. If your DVDs are on your hard drive, they can't be lost or damaged. The RipIt application allows you to organize files on your computer rather than on your shelves. Then, use Spotlight to locate your movies.

Reviews say this application's performance is stunning and takes up just 21 MB of RAM and a maximum of 18% CPU on a Core Duo 2.0 GHz on iMac. The user interface is extraordinarily simple with two choices: "Eject" and "Rip." You can download a seven-day free trial and/or buy it for \$18.99 online.

New in iPhoto '09 is the feature for face detection and recognition. THUNDERBIRD VS MAIL

Thunderbird email works well for those using OS 10.3 and below—in fact, it really is a necessity for 10.3 and below. Drawbacks for Thunderbird are that it doesn't recognize Apple's Address Book nor can you email pictures from iPhoto. It's a great stand-alone application, but it doesn't integrate with Apple applications. Mail, on the other hand, had too many problems for 10.3. Now, however, with Tiger and Leopard, Mail is the application that works well.
