ADOBE FLASH PATCH

Thursday, February 7, 2013

In a security advisory published on Thursday, February 7, 2013, Adobe announced the immediate availability of a patch covering two newly discovered Flash vulnerabilities that are being exploited "in the wild."

Adobe is also aware of reports that CVE-2013-0634 is being exploited in the wild in attacks delivered via malicious Flash (SWF) content hosted on websites that target Flash Player in Firefox or Safari on the Macintosh platform, as well as attacks designed to trick Windows users into opening a Microsoft Word document delivered as an email attachment which contains malicious Flash (SWF) content.

The Adobe Flash patch can be found on the company's website, and users can visit this page to check if their software is the most current 11.5.502.149 version.

iCLOUD

SET UP iCLOUD ON ALL YOUR DEVICES http://www.apple.com/icloud/setup/mac.html

The above Apple website will get you going on iCloud in a "few easy steps." You need OS X v10.7.4 or later to use iCloud that you can purchase from the Mac App store. Once you have the app, you go to System Preferences from the Apple menu and select the services you want. You can choose to get the free iCloud email account and activate it using the onscreen instructions. Once iCloud is up and running, get all your devices synched in a few easy steps.

Splashup, formerly Fauxto, is a powerful editing tool and photo manager. With the features professionals use and novices want, it's easy to use, works in real-time and allows you to edit many images at once. Splashup runs in all browsers, integrates seamlessly with top photo-sharing sites, and even has its own file format so you can save your work in progress.

VENDING MACHINES AND MACBOOKS

You can buy iPods at airports, iPads at Macy's, and you can borrow MacBooks from a vending machine at Drexel University in Philadelphia.

A vending machine at Drexel University lets you borrow a MacBook for up to 5 hours. The reason for this unique service is to help increase on-campus safety. If students are concerned about carrying their own laptop between their dorms and the library, they can borrow the laptops from the machine.

The vending kiosk, which carries 12 MacBooks at a time, lets anyone with a Drexel ID borrow a laptop for up to five hours, with a \$5 charge for late returns. Laptops get charged and wiped of any data while they rest in the vending machine, so students don't have to worry about a dead battery or data security issues. When a MacBook is returned to the kiosk, the docking station begins charging it for its next use. Additionally, the laptop's hard drive is wiped with each return, so students do not need to be concerned about their projects being stolen. On the other hand, any work produced during a rental session will need to be saved through a cloud service to avoid data loss.
