"HI, SPEED" APPLE SPECIAL EVENT 11 MDT TUESDAY, OCTOBER 13, 2020

This big Apple event will present the iPhone 12 in various colors and options including

5K—therefore, the clever "Hi, Speed" event title and logo colors, possibly representing the new iPhone colors.

As is mentioned in ads, you must have a 5K device to get 5K speed.

Update from the "Hi, Speed" Apple October 13, 2020 event: Apple says new iPhone 12 models have:

 Apple's A14 Chip ("fastest smartphone chip in the world," 50% faster than chips powering other smartphones).

- Front glass is 4 times more durable.
- Magnets are inside phones so that wireless chargers can snap on more easily.
- All models have more advanced cameras.
- Preorders October 16: iPhone 12 and iPhone 12 Pro. Shipping October 23.
- Preorders November 6: iPhone 12 mini and the 12 Pro Max. Shipping November 13.



BIG SUR MACOS 11

MacWorld says, "It's a tidy up and a spring clean rather than a brand new macOS"

Big Sur, macOS 11 is coming soon. The Beta testing has been going on for months and the public Beta is out now. Some Apple geeks suggest that before upgrading to Big

Sur, it might be wise to put it on a different computer, e.g., your laptop vs your desktop, to experiment with it before committing to this change. The following comment from MacWorld is also worth noting.

But we just feel that this time round there isn't anything to make us stop in our tracks. It's a tidy up and a spring clean rather than a brand new macOS. The real changes are happening under the hood and until we get the Silicon Macs we won't really benefit from them.

Many will be pleased to hear the return of the familiar Mac chime that we used to hear when Macs started up (most Macs sold since 2016 have been silent in their start up).

The free macOS11 Big Sur software update will be released to all users with a compatible Mac in the fall, according to Apple.

- 2015 and later MacBook
- 2013 and later MacBook Air
- Late 2013 and later MacBook Pro
- 2014 and later iMac

Accordingly, the following models capable of running macOS Catalina *will not* be able to be upgraded to macOS Big Sur:

2012 and Early 2013 MacBook Pro

PREDICTION FOR WHEN FIRST APPLE SILICON MACS WILL ARRIVE

Multitudes of online Apple tech writers and reviewers have been busily predicting when the new Apple Silicon Macs using the custom chips will be available. In these unusual times with production delays, it is difficult to separate the wheat from the chaff, but the "reliable analyst Ming-Chi Kuo"* says it will be in November 2020. Likely the first Apple Silicon Macs would be a MacBook Pro and a 24-inch iMac. 9-5Mac online writer Michael Potuck says this is confirmed by Bloomberg as well.

* Ming-Chi Kuo is an analyst at TF International Securities, a financial services group in the Asia-Pacific region. He gathers intelligence from his contacts in Apple's Asian supply chain, translating the information he gleans into research notes for clients.
