iOS 14.5 ADDS AN OPTION TO UNLOCK iPHONE WITH APPLE WATCH iF YOU'RE WEARING A MASK

If you have an Apple Watch and use Face ID, you can open your iPhone iOS 14.5 while wearing a face mask IF the devices are paired together. Then the iPhone will unlock after a partial face scan. Engadget says, "While the full release won't arrive for some time, Apple just released the first iOS 14.5 developer beta today (02-01-2021). "This feature must be manually enabled before use, allows Face ID to open the iPhone even with very little facial recognition than is normally required because your Apple Watch has been authenticated. Also be aware that approving App store purchases will not work using this Apple Watch/iPhone Face ID combination. Apple has been working on this workaround since May 2020 when an update prompted you to use the passcode input screen.

PRIVACY CONTROLS IN APPLE IOS AND SOME POSSIBLE "EXPLORATION" PRIVACY CONTROLS FOR ANDROID (GOOGLE)

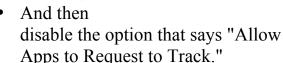
Remember, Apple's privacy system applies only to Apple iOS, and Google's privacy system applies only on Android. So when you consider what to do about Apple tracking you on your devices, you have user control—you control or don't control what Apple tracks—and they do track what you do online. Other systems track you too, but at this point the user doesn't control what is being tracked. It's just putting the owner in charge of access to a resource that, heretofore, they didn't realize companies were taking from them without asking.

The exploration into an Android alternative to Apple's feature is still in the early stages, and Google hasn't decided when, or if, it will go ahead with the changes. (From Daring Fireball by John Gruber.)

FYI: Apple requires app developers to ask for permission before they track you. If you give permission to be tracked developers can collect data including your name, email address (or other identifying info you provide), combined with info about you or your device collected by third parties. This information can be used by the app developer or third parties for purposes of targeted advertising; additionally, the app developer may chose to share this information with data brokers. DUCKDUCKGO VERSUS GOOGLE

Writer Bradley Chambers writing for 9to5 Mac has compared search engines Google and DuckDuckGo. He explains what each search engine does and what it does with your usage of it. Of course, the reason for this comparison is to determine whether and how much data about us we want to share about our internet usage.

A common misconception, he says, is that Google (and Facebook) collect all this information and "sell" it to other companies. Chambers writes that the data is so valuable they want to be the only ones that have it so they sell access to your data by letting companies advertise to use it in a targeted way based on what Google and Facebook know about us. This seems like a convoluted way of saying they sell our data, but it's not, they say. Advertisers pay Google (and Facebook) to advertise on what we have looked at so the next time we look at whatever, we get to read the ads the companies pay to put there.

I doubt that I'm outfoxing the fox, but when I use a search engine, I make an effort to go to be bottom of the list of requested information to see what's there before I look at the top "AD" shown.

Mr. Chambers shows how to designate your preferred search engine as the default. He also says (spoiler), "Google is better but I still use DuckDuckGo." Go to 9to5mac.com and look for his complete article. Copy and paste this website to see article:

To check the battery for macOS Big Sur 11.2.1, go to:

- System Preferences App and click the Battery option.
- Select Battery in the sidebar and click Battery Health.

For Mac computers running macOS Catalina:

• Hold the Option key and click the battery icon in the menu bar
