**DAPI MEETINGS Now with FM
HEARING ASSISTANCE**

DAPI has added an FM radio transmitter to be used during our audio/visual presentations at Applewood Community Church! **This means that those attendees who have trouble hearing can bring their own FM radio and earphones to hear the presentation. Note, please bring your own earphones;** the club does not have any to loan out. You must use earphones while using your FM device otherwise there will

be feedback and a horrible ringing will result!

You can use any portable radio that receives FM signals, including a Sony Walkman. The FM signal may be 88.0, or if not this frequency, you will be told which frequency to tune to.



DAPI member Tony Bilelo suggested this addition to our presentations as his local church uses a similar transmitter for church services (although a more powerful model for larger audiences). Tom King and Larry Fagan installed the transmitter at AWCC at our last HelpSIG meeting.

**NEW SOFTWARE ANNOUNCEMENTS FROM
WWDC 2021 - JUNE 7, 2021**

This session of WWDC was virtual, as it was last year, and its announcements were about iOS 15 for our portable devices and the Monterey OS for our desktop Macs.

Tim Cook says the iOS 15 will likely be released to the public this fall, maybe September, to coincide with the release of iPhone 13, depending, of course, on the supply chain.

iOS 15 will run on any of these devices: iPhone 12, 11, and XS series, iPhone X and XR, iPhone 6, 7 and 8 series, iPhone SE

(both generations) and iPod touch 7th generation. Some new features require an A12 Bionic Chip or later, so the older phones won't give the full-featured update, but they will work.

MacOS Monterey requires one of the following Macs:

- Late 2015 and later iMac
- 2017 and later iMac Pro
- Early 2015 and later MacBook Air
- Early 2015 and later MacBook Pro
- 2019 and later Mac Pro
- Late 2014 and later MacBook
- Late 2013 and later Mac Pro

Many new features are very sophisticated including Spatial audio, voice isolation, portrait mode, FaceTime links, SharePlay and many others. For a boiled down summary, go to:

SIRI TRICKS ON IPHONE

First of all, you need to set up Siri: Go to Settings > Siri & Search > choose how you want to enable Siri.

1. To make a FaceTime call say, "FaceTime Jim," or whomever you want to call and Siri will dial that person. The person you call needs to be in your contacts.

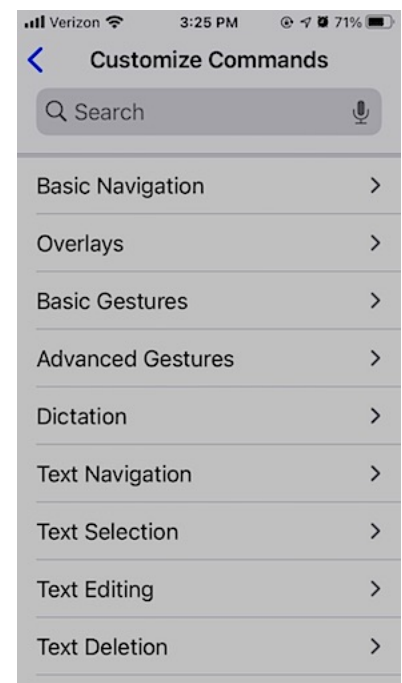
2. Set an alarm or timer: "Hey Siri, set an alarm for 4 pm." Much easier than fumbling with your device's clock and alarm options.
3. Turn on Flashlight: "Hey Siri, turn flashlight on." or "Turn flashlight off."
4. Check Stocks: "Hey Siri, how is Apple stock doing today?"
5. Reminders App (download from Apple Store). "Hey Siri, Remind me to feed the cat when I get home." Once you start using reminders, be sure to set up your iCloud so all your devices are synced.

Voice Control But No Siri

Using iPhone's iOS 13 (or newer), another command on your iPhone is called "Voice Control." For instance, after you set Voice Control up, you can say, "Swipe left" or "scroll up" to move where you want on your screen. You can also open apps and take pictures with your front or rear camera with a simple command.

You can also customize commands. Go to Systems > Accessibility > Voice Control > Customize Commands. After you click *Customize Commands*, then go thru list of



commands that are divided into groups based on functionality such as Basic Navigation and Overlays. Go to the website to follow the step-by-step instructions for creating these actions.
